

There are several important issues on the ballot this year, and it is very important that you vote if you wish to have a say in your community. Argus will be mailing ballots and proxies soon, so you must alert Argus or a Board member if you will not be here so that these items can be sent to you wherever you are. If you will be unable to attend the meeting, be sure to give your sealed proxy to a trusted neighbor or Board member

The important issues to be voted on are:

1 Removal of the 10 Washingtonian Palms at the

main entrance to the Cottages of Rivendell.

2 Should trees and shrubs outside of the common areas be replaced by the Association or by individual homeowners?

3à Should interior lot owners be allowed to install sidewalk extensions to the street?

3b Should the cost of sidewalk extensions be at the Homeowner's or Association's expense?

## Meadow Sweet. Cuisine...

White Chocolate Pumpkin Macadamia Cookies. Compliments of Tracy Arendt

2 cups all-purpose flour 2 teaspoons ground cinnamon

1 teaspoon ground cloves

1 teaspoon baking soda

1 cup butter or margarine

1/2 cup granulated sugar 1/2 cup packed brown sugar

1 cup LIBBY'S® 100% Pure Pumpkin

1 large egg

2 teaspoons vanilla extract

1 (12 ounce) package

2/3 cup coarsely chopped macadamia nuts



HOLIDAY COOKIE **EXCHANGE** 

PREHEAT oven to 350 degrees.

COMBINE flour, cinnamon, cloves and baking socia in small bowl. Beat butter, granulated sugar and brown sugar in large mixer bowl until creamy. Beat in pumpkin, egg and vanilla extract until blended. Gradually beat in flour Mixture. Stir in morsels and nuts. Drop by rounded tablespoon onto greased baking sheets; flatter slightly with back of spoon or greased bottom of glass sopped in granulated sugar. BAKE for 11 to 14 minutes or until conters are set. Cool on baking sheets for 2 minutes; remove to wire racks to cool completely.

Everyone brought their very best cookies to swap so that we all enjoyed a wonderful variety without ending up in the kitchen all day. This was another outstanding event for our community, which added much joy to the holiday season.
